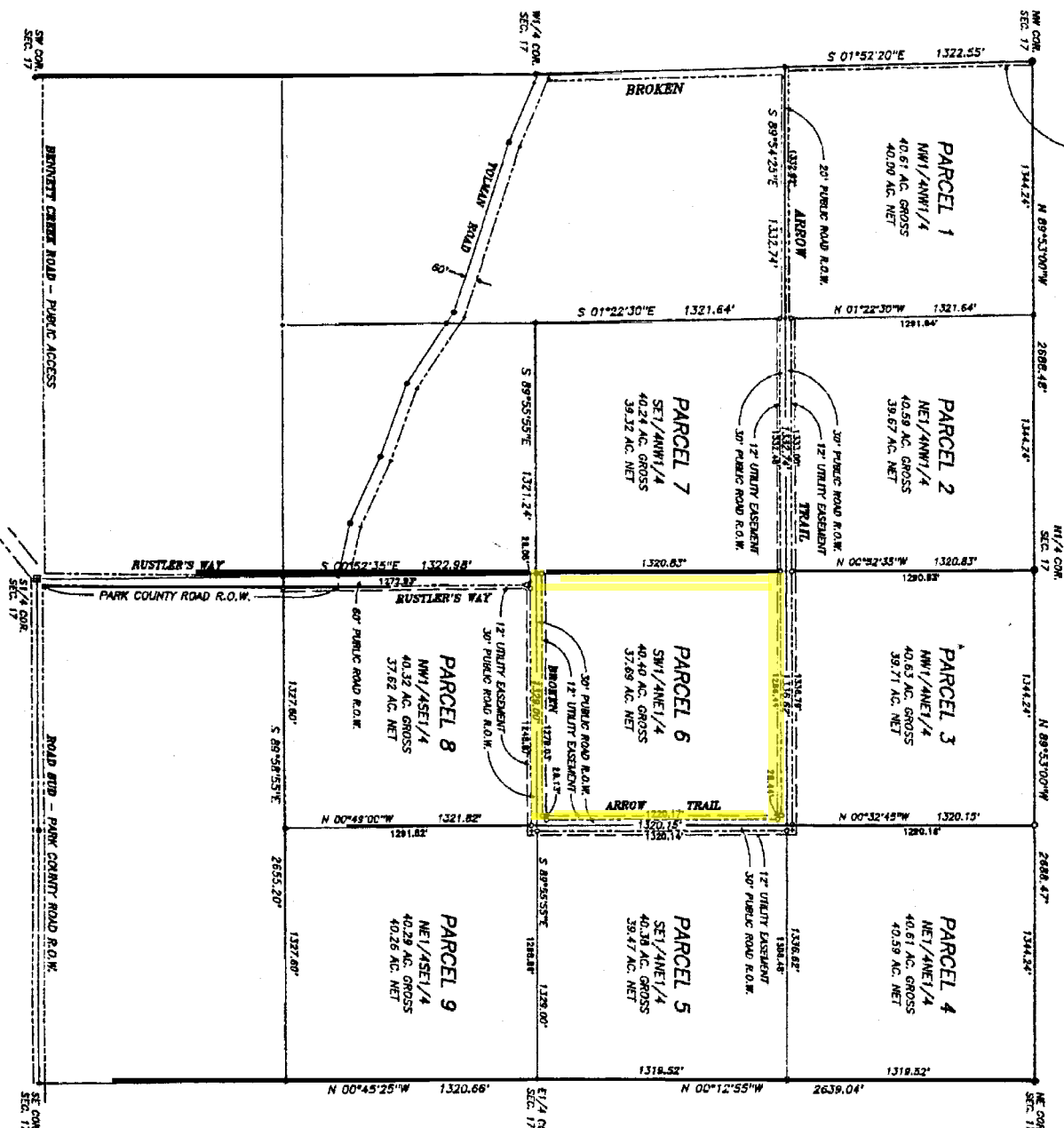
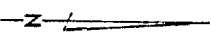


20' WIDE PUBLIC EASEMENT FOR ACCESS TO R.L.M. LANDS NO MOTORIZED VEHICLES
