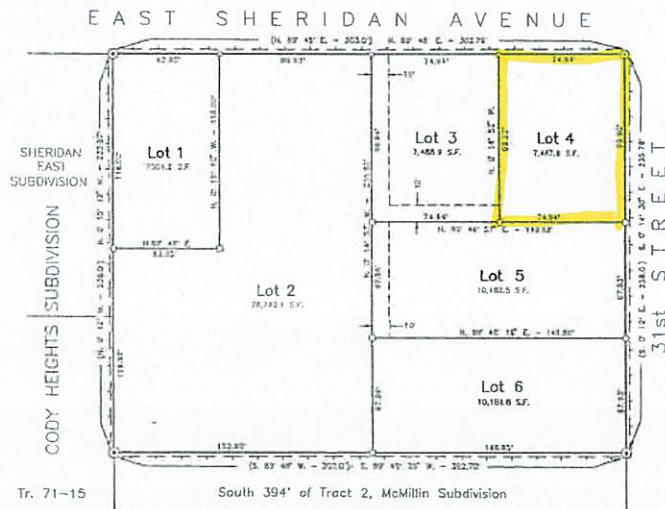

CERTIFICATE OF SURVEYOR

I, Richard E. Myrick of Powell, Wyoming hereby certify that during the period from May 20, 1993 to August 30, 1993, the Homestead Subdivision was surveyed by me and under my direction that said subdivision is correctly described in the owner's Certificate of Dedication on this Plat, which is drawn to a scale of 1 inch equals 30 feet. The dimensions of lots are given in feet and decimals of a foot, and any surplus or deficiency is distributed uniformly in proportion to the measurements shown on this plat. Each lot bears its own number. All lot corners are as shown on the plat. All elements of the survey close to 1 in 5,000, or better. The North line of Tracts 1 and 2 of the McMillin Subdivision, bearing N. 89° 48' E., was used as the Bearing Base for all of the bearings obtained during this survey.

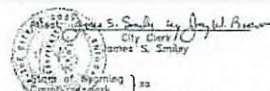
